Mohawk Valley Library System Director's Report March 2019

Administration & Governance

The state budget has been approved. It was a somewhat disappointing year for libraries. The final budget did restore the library operating aid to last year's numbers, with no increase. What this means is that our funding is still below 2008 levels, with no appreciable increase since 2016. Obviously, the statewide library advocacy process needs some work.

Public Library Construction funding was cut from \$34 million to \$14 million, which will probably reduce the MVLS share from last year's nearly \$900,000 to \$370,000. There is some talk that there may be additional money made available for library construction after the state gets better income projections, though it is unclear how any such funding would be allocated.

The budget was also disappointing in census funding for libraries. \$20 million was allocated for complete count activities, but at this point it seems unlikely that libraries will receive much – if any – of that funding. It is slated to be distributed through the regional economic development councils. There may be some opportunity to advocate for libraries to receive some of that funding, so stay tuned to your NYLA emails.

The MVLS State Annual Report was submitted in March. The report requires board approval to be official. The report is available on the MVLS website at: https://www.mvls.info/wp-content/uploads/2019/04/MVLS-2019-Annual-Report.pdf This will be an action item at the April meeting.

Automation and Resource Sharing

The JA Council will meet at SALS on May 8. Several issues are keeping the JA Council busy. We continue to implement the e-card software, and while the address verification databases are not perfect, libraries are very pleased with the new, accurate data. JA, particularly on the MVLS side, is working to establish standards for libraries that want to go fine-free. The fine-free movement is expanding all over, and it is great to see MVLS libraries embracing this trend. I have been putting together information on the JA fee structure. Every few years there is a little agitation (never from an MVLS library) from a library or two about the appropriateness of the fee

structure. At the next JA meeting we will be reviewing a spreadsheet that provides information on the fees paid by each library and on the relative size of member libraries, based on various annual report statistics. As a data and numbers guy, I find it interesting and instructive. The bottom line is we have a very just fee structure, and the data bears that out.

We are also working to develop a better rubric for determining how library telecommunications service is provided and cots are paid. Historically, JA provided and paid for telecommunications, but as both library public access computer use, and later wireless access use, has skyrocketed, libraries have wanted better access and greater bandwidth; and they have been willing to pay for that. This has led to a wide variety of service parameters and costs, which leads to disparities in service and costs shared among the member libraries.

Each year in May – June the member libraries look at system-wide e-resources to make decisions for the next year. This year we will not only be discussing budget and cost sharing as usual, but will also be looking at ways to expand our e-resources offerings.

We continue to monitor delivery issues. There have been some staffing challenges and changes, and some computer equipment was damaged.

Outreach Services

The next 3-year cycle of state Adult Literacy grants has been submitted to the state. The project is tailored to the needs at the participating libraries: Schenectady, Johnstown, Middleburgh and Schoharie. The program remains focused on resources and programs to build job skills.

Adult Services

The 2019 NYSCA series is now set to go. This year the program was changed to encourage a greater variety of literary programs. Now called "Pen & Ink", the series will feature book discussion and writing programs. A schedule will be shared soon.

The Library Moon Walk project finishes up at the end of April. It was been a very positive collaborative project between the Mohawk Valley, Southern Adirondack and Upper Hudson Library Systems. Many libraries have done innovative programs. Of special note was the Health Fair sponsored by the Middleburgh, Bern and Rensselaerville Libraries.

She is also working on updating our Start with Science kits with current science and early literacy techniques, and developing additional kits

The annual Stewart's Grant for graphic novels was received in March for \$750.

Picture Book City labeling is continuing at SCPL branches, and will take place at Central later this year. Libraries are scheduling Science @ the Library programs for spring and summer.

We continue to assist Johnstown with their transition to a school district public library, and with setting up their new foundation. Middleburgh's charter amendment application is going forward, and we are exploring a charter issue with Canajoharie.

I am writing this at the end of National Library Week. Wade produced as press release and has been working with libraries on social media and video projects to promote libraries this week.

Wade is beginning to work on a fall state advocacy effort that will be focused on getting MVLS and local library representatives to visit the regional offices of their state representatives. The idea is for MVLS to coordinate an effort to have more leisurely, detailed and informative discussions than we can manage on Advocacy Day. This has been on my to-do list for years, so it is great to see it finally happening.
